Who is Ohio Statewide Development Corporation?

Ohio Statewide Development Corporation (OSDC) is a private, non-profit corporation that provides financing to Ohio small businesses. We partner with conventional lenders like banks and credit unions to help businesses purchase real estate and equipment. By partnering with OSDC, your business gets access to financing that requires a lower down payment than when using conventional financing alone. OSDC financing also comes with a below market, fixed interest rate for the entire term of the loan.

Why is it important to disclose ALL personal information when applying for a loan?

The loan programs OSDC provides use extensive databases to screen applicants. These databases provide access to information that you may have forgotten or thought expunged. When non-disclosure occurs, it is often due to the applicant forgetting something from a long time ago, not realizing records exist, or thinking because an event was expunged it will not show in a search.

We recommend the following best practices to increase the likelihood of loan approval:

- 1. Answer every question fully and completely
- 2. Disclose events from any time / any place/ any court /any age
- 3. Disclose answers related to:
 - a. Pending or resolved criminal matters
 - b. Pending litigation
 - c. Disputes regarding indebtedness even though settled by payment of a settlement
 - d. Fully disclose these even if:
 - i. You thought it was "expunged" or that the record had been "sealed"
 - ii. It was a long time ago; you were a minor; or it's not on your credit report
 - iii. You are embarrassed or it was just a misunderstanding
 - iv. You were only a guarantor

Derogatory information about an applicant's past is rarely disqualifying unless it is not disclosed and later discovered by OSDC in connection with its due diligence.

Definitions:

- 1. **Operating Company (OC)** An eligible small business
- 2. **Eligible Passive Company (EPC)** A real estate holding company for an eligible project
- 3. **U.S. Small Business Administration (SBA)** Federal agency charged with the responsibilities of supporting the growth and prosperity of the small business sector operating in the United States and owned by US citizens.
- 4. Certified Development Company (CDC) A company licensed to offer 504 loan products by SBA.
